Interoperability Study Group (ISG)

Chartered in the Helsinki Plenary Meeting 2005 via Resolution 856 in order to:

- Investigate the possibility of additional standards or guidance in the area of Interoperability.
- Assess how SC7 standards address interoperability issues and come with recommendations.

The ISG was to take into consideration Interoperability standards from other ISO groups such as TC184/SC5/WG1

ISG Progression

Helsinki:

- ISG met first time; chair / co-chair prepared / distributed preliminary action plan

Bari:

- Chair / co-chair unable to attend; meeting call / agenda / presentation prepared / distributed.
- TC184/SC5/WG1 (liaison) member prepared material on InterOp / ATHENA / new Interop Std
- Low attendance - apparently low interest in this topic

Action Items

ISG Progression

Post Bari:

- Limited time available for chair to prompt ISG members into action; co-chair unavailable.
- ISG action plan items have not been advanced
- Low amount of feedback on action plan topics

Bangkok:

- Tentative meeting (Wed pm?) / informal consultation to decide whether to extend the group or dismantle it.

What Next ?

- Interoperability is an essential issue. However, there is no consistent meaning associated to this term, sometimes even within ISO SCs.
- Significant work is done by other ISO SCs. Should SC7 put effort in this area as well or take results?
- It appears currently there is not enough interest in this topic within SC7
- Therefore, subject to the outcome of the tentative ISG meeting, it is proposed that ISG be disbanded.
